

## TERMS & CONDITIONS: AUDI FOUNDATION PRIZE DRAW 011

## **WINNER DETERMINATION**

## **WINNER NOTIFICATION & PRIZE COLLECTION**

There is one prize. The prize is an Audi Q5 Sportback TFSI e plug-in hybrid in Navarra Blue (Prize).

- Metallic paint and 20" Audi Sport alloy wheels in 5-V-spoke star design, gloss anthracite black, partly polished included.
- Value: \$125,148 (drive away)
- 2.0 TFSI engine producing 195kW and 370Nm of torque paired with an electric motor outputting 105kW and 350Nm of torque for a combined output of 270kW and an impressive 500Nm.
- The 14.4 kWh battery allows a driving range of up to 53 kilometres of purely electric, emission-free driving at speeds of up to 135km/h.
- Its 14.4kWh battery (17.9kWh gross) can be charged at up to 7.2kW AC for a full charge in around 2.5 hours.
- 0-100kms: 5.3 seconds
